Since my appointment as Chief of Police here in Springer, I have seen a large number of things that do not sit well with me as a law enforcement officer. My first person to person meeting with Mayor Cruz amounted to him handing me a copy of Ordinance 272 with the Mayor's power to hire and fire highlighted. Since that time I have received two more of the same. Mayor Cruz called me at one time on the phone and told me to fire a police officer because of rumors. When I refused he told me to do an investigation on these rumors. I did a thorough investigation and found no wrong doing. This must not have been what he wanted to hear as the officer's probation was extended even though he was off probation. The officer finally resigned. Martinez was placed on administrative leave a few hours after he effected an arrest. He was told to turn in all of his equipment, and told he had no police powers what so ever. When the officer asked what he was being suspended for, Mayor Cruz would not tell him the details. Officer Martinez was not allowed to even sign his suspension. He was later terminated before the Attorney's investigation complete. Now Officer Mondragon has to ride along with one of the two remaining certified police officers because Mayor Cruz feels that he is not trained well enough to be alone on patrol. Officer Mondragon has ridden

A Letter to the Citizens with Officers Aguirre and Martinez and studies his manuals constantly. He has received training through the Law Enforcement TV Network that is accepted by the Department of Public Safety in New Mexico. I have discussed at length with Officer Mondragon different scenarios traffic stops and handling numerous situations. am a veteran police officer and feel that this officer is doing well.

Mayor Cruz's memo came after an arrest that Officer Mondragon effected. The entire arrest was taped. I went to the Police Station the night of the arrest and okayed what the officer did. I reviewed the tape and agreed that Officer Mondragon had acted professionally without malice, even when the suspect cursed and accused the officer's wife. I have this tape in evidence if anyone would like to hear it. This tape shows what we officers put up with in one form or another on nearly a daily basis. I feel that most officers I know are doing their work because they are dedicated and because they can make a difference, surely not for the money. We put the money. We up with drunks with druggies. Their filthy mouths and attitudes, and disrespect for the law and police. We feel that we received we received enough hassle from the general public without having to worry about being fired every time we do our job. And, what we do is, in fact our job. We are sworn in by oath to enforce the law on all people, not just a chosen few. As Chief of Police I

have been charged with the running of the Police Department and seeing that the law is enforced. I have found this increasingly harder as law enforcement officers are in and out of here like water through a seive. Each time we get a good investigation started on some of the crimes and drugs, (which are a lot more than I think you realize) one of the officers gets terminated. I feel that the people of Springer, and the Town Council for that matter, are misinformed on certain issues. I would like to say that Officer Mondragon was hired by Mayor Cruz. Mayor Cruz knew at that time that he was not trained and we had numerous trained officers apply. I was on the interview committee and was never asked what recommendation was. Mayor Cruz, you are not a Police Officer, nor were you trained to be one. I do not understand why you take these actions upon yourself without even looking into evidence, or questioning the officer in question. Law enforcement is not an easy task, no one likes to get caught in their wrong doing. I feel that since Mayor Cruz obviously does not care about the evidence or the police side of the story, maybe an appointed Police Commissioner to the Department may be in order. This evening's agenda calls for maybe another termination of a police officer. We of course were not told who this officer is. So we all have to wonder what is happening and who, with no chance to prepare a defense. Police Officers have rights too. Being from Springer does not immunize one from obeying the law. I immunize

Many times Ed gets home and before has a chance to eat dinner, he is called out again and doesn't have a

Holidays are no exception. When you are enjoying your they're out home homay working. Ed worked Thanksgiving, he worked Christmas Eve and and New Christmas Eve and Christmas Day and New Year's Day. He worked so his officers could spend time with their families.

When you're in your nice warm house, they may spend hours standing out in the rain and snow handling an accident -- or waiting with a family who just lost a loved one -- or helping a stranded motorist -- or looking for Boys' School escapees -or helping someone get their livestock off the highway -- or finding a place for a woman and her children because her husband beat her up and threw her out of house -- or finding a place for a child who can't go back into an abusive home -- or taking a report on a break in somewhere -- or sitting out in the cold and dark on a tip of an inpending

crime.
Their lives are on the line every day -- they're spit at, assaulted, and called every foul name in the book, threatened with their jobs and expected to take it all.

The people who aren't involved in these things don't seem to understand that they do happen. I've heard over and over again, "we don't need police in Springer -- nothing ever happens here."
